Treasurer's Report Jim Hrabosky reviewed the June and July Operating, Capital, Academic Enhancement

and Restricted Funds Budget Summaries, as well as the Enrollment Report. The Budget

President's Report Dr. Neupauer reported on the following:

**State Activities** 

-Dr. Neupauer attended a meeting of the Community College Presidents last week. The topic of discussion was "what-if" scenarios if the state budget is not passed soon.

-The lack of a state budget will have an impact on our grant programs. ACT 101, New Choices/New Options and Dual Enrollment are likely to be eliminated in the state budget.

Staff is working into August, then on a month-by-month basis.

-The state budget will continue to be an area of concern for at least the next two years.

### College Activities

-The College will be closed on September 7 for the Labor Day holiday.

-BC3 has experienced the most growth as compared to the other PA community colleges. -After the 8/07 purge, enrollment was up 16.2% over this time last year. The number of credits sold is up 17.3% (3,000 more credits than fall 08-09). Enrollment increases by location: Main Campus increased 10.5%, Lawrence County increased 30%, Mercer County increased 20%, other PA counties increased 32.5%, out-of-state increased 20%.

We have 3,900 credit students enrolled to date. -The College's strategic plan is being finalized.

- -A meeting was held on 7/30 with Lt. Governor Scarnati to discuss BC3's role in Jefferson County as part of an 11-county consortium.
- -Francie Spigelmyer held a part-time faculty orientation on 8/15, with over 70 in
- -The LindenPointe expansion project is in process.
- -The Nursing Division received \$37,000 from PHEAA and \$8,500 from the Edna McKenzie Scholarship.
- -Dr. & Mrs. Neupauer will co-chair the 2010 March of Dimes walk-a-thon on 5/01.

# **Committee Reports** Executive

Mr. Schultz reported that the Executive Committee met on 7/31 to consider a change order to the Pioneer Café Phase II renovation. In order for the project to be completed in time for the start of the fall semester, the change order request needed to be brought to the Board before today's meeting. The Board gave the Executive Committee authorization to act on its behalf in such circumstances, with ratification of the action at the next regular meeting. The Committee approved a \$320,595 add to the R.A. Glancy & Sons, Inc. contract to add an outdoor seating area and the renovation of restrooms to meet applicable building code.

Mr. Schultz moved to ratify the Executive Committee's action taken on 7/31/09, to approve the Change Order of a \$320,595 add submitted by R.A. Glancy & Sons, Inc. Motion Carried.

Mr. Schultz reported that the Finance Committee met on 8/14 to discuss the Mercer County expansion project and business plan; potential cash generators; projected statement of cash flows as related to the delay in the adoption of the state budget; impact of enrollment numbers, using reserve funds to balance the budget and preparing for the 2010/11 budget.
