President's Report Dr. Neupauer reported on the following:

State and Federal Activities

-Community colleges are the only sector of higher education to receive an

increase from the state in the latest budget. BC3 will receive an additional

\$125,000.

- -Dr. Neupauer met with PA Education Secretary, Carolyn Dumaresq, on August 7.
- -Dr. Neupauer led the community college presidents' retreat on August 13-14. There are currently five new community college presidents in the state and three with less than two years of service.
- -The annual All-Trustee Assembly is scheduled for September 25-26 in Harrisburg. Jim Ferguson and Nancy Staible are attending.
- -The PA Commission is developing a new strategic plan.

College Activities

- -Fall enrollment is off to a great start as compared to sister colleges. BC3 leads the state with enrollment that is close to last year.
- -The fall convocation was held on August 21.
- -50th anniversary activities are in process.
- -Internal giving to the Pioneer Proud campaign is currently at 70%.
- -The annual county budget presentation is scheduled for October 2.
- -The Debt-Free at BC3 campaign is going very well. Kudos to Susan Changnon and her staff.
- -Dr. David Anderson had an article published in the spring 2014, *The Hemingway Review*. The article is titled, "Hemingway's Early Education in the Short Story: A Bibliographic Essay on Brander Matthews and Twenty Volumes of Stories at Windemere."
- -Ruth Scott is retiring this week after 42 years. Thank-you, Ruth, for great service to BC3.
