Dr. Neupauer reported on the following:

State and Federal Activities

-Dr. Neupauer attended the National Legislative Summit in February. Much of the discussion was on President Obama's free community college proposal.

-The College is getting much press coverage regarding the Prior Learning Assessment initiative. Only the *Post-Gazette* put a negative light on it.

However, they printed a rebuttal from Dr. Neupauer.

-Dr. Neupauer is testifying before both the PA House and Senate on March 19,

on the topic of community college funding.

-The PA Dept. of Education confirmed community colleges will receive a 7% increase in funding next year, pending final budget approval by the Legislature.

-Dr. Neupauer and Jim Hrabosky will attend a meeting at Harrisburg Area

Community College on March 20, to discuss a new funding model.

- -On March 24, Dr. Neupauer will speak to college and university presidents at the annual meeting of the Association of Independent Colleges and Universities of Pennsylvania.
- -Ms. Geyer and Mr. Steffler will join Dr. Neupauer and staff at the annual meeting of the PA Commission for Community Colleges and Lobby Day activities on April 13-14. Six BC3 students will also participate in Lobby Day.

College Activities

- -The College will be closed on April 3, in observance of Good Friday.
- -Thank-you to Ms. Geyer and Ms. Hawkins for their participation in the tour of Westmoreland County Community College's Advanced Technology Center on March 2
- -Thank-you to Susan Changnon and the 50th Anniversary committee for their work in the celebration of the College's charter on March 3.
- -Dr. Thomas Ten Hoeve will be the keynote speaker at Commencement on May
- 20. There will be a reception from 2:30-4:00 p.m. in his honor. He will attend the board meeting at 5:00 p.m. as well.
- -Dr. Neupauer reported that BC3 is establishing a presence in Armstrong County.
- -The Nursing and Allied Health division hosted an accreditation team in January. Results of the visit will be shared in June.
- -There is much interest in the Degree Completion Partnerships that were established on February 25.

Mr. Steffler reported there was a joint meeting with the Facilities committee on March 3. Agenda items included an update on the Heaton Family Learning Commons, student housing, a history of enrollment for Armstrong County students, timbering opportunities, the current budget and the timeline for the 2015-16 budget preparation.

- -Brian Opitz reported he is conducting an evaluation of College property as related to timbering. The Butler Area Sewer Authority is considering timbering some of their property. - -A design development package with 87 drawings of the Heaton Family Learning Commons was received. A meeting will be held on March 19, with the stakeholders. The name of a construction company will be presented to the board for approval at the June 16, board meeting. Construction is expected to be complete by June 2016.
- -The main entrance signage was fabricated over the winter. It will be built in April and installed in time for the May events.
- -Mr. Rittelmann and the Facilities committee have discussed the bricks and mortar needs for the future of BC3. We do not currently have a good handle on this. Mr. Rittelmann has spoken with Dr. Spigelmyer and Ann McCandless for their input. This is a heads-up as more discussion needs to take place.
