All Certifications have limited enrollment. To reserve your spot you must submit a completed/typed certification application, supporting documentation and a BC3 Class Registration Form by the application deadline or before the certification is full.

Lunch will be provided to candidates on Practical Skills Exam Day. Doesn't include HMA Certification

**Closed Test** - These certifications are not open for public enrollment without the permission of the hosting organization. Any organization that meets the minimum number of candidates, can schedule a closed certification.

**Off-Site Testing** - To increase accessibility of certifications, we can deliver certain certifications locally. Requests must be submitted at least 120 days before the certification date. Off-site testing are normally for HMA, Driver/operator series & Fire & Emergency Instructor series.
