Certification Information

All Certifications have limited enrollment. To reserve your spot you must submit a completed/typed certification application, supporting documentation and a BC3 Class Registration Form by the application deadline or before the certification is full.

Lunch will be provided to candidates on Practical Skills Exam Day.

Doesn't include HMA Certification

Closed Test - These certifications are not open for public enrollment without the permission of the hosting organization. Any organization that meets the minimum number of candidates, can schedule a closed certification.

Off-Site Testing - To increase accessibility of certifications, we can deliver certain certifications locally. Requests must be submitted at least 120 days before the certification date. Off-site testing are normally for HMA, Driver/operator series & Fire & Emergency Instructor series.
